

THE 17th ANNUAL NEWPORT BRIDAL SHOW

1. **Entry Period:** The 17th Annual Newport Bridal Show Grand Prize Drawing entry period begins at 11:00 a.m. Eastern Time ("ET") on March 3, 2019 and ends at 4:00 p.m. on March 3, 2019 (The "Entry Period").
